## Three-distance theorem

Let $\alpha$ be given and let us place the points $0, \alpha, 2 \alpha, \cdots, N \alpha$ on the unit circle

Theorem The points $0, \alpha, 2 \alpha, \cdots, N \alpha$ partition the unit circle into intervals having at most three lengths, one being the sum of the other two


## Three-distance theorem

Let $\alpha$ be given and let us place the points $0, \alpha, 2 \alpha, \cdots, N \alpha$ on the unit circle

It is also called the Steinhaus theorem, the three length, the three gap, or else, the three step theorem

It was initially conjectured by Steinhaus, first proved by V.T. Sós'58, Surányi'58, Slater'64, Świerczkowski'59, Halton'65

There exist various types of proofs: arithmetical, combinatorial, dynamical, geometry of the space of $2 d$ lattices, etc.

The lengths correspond to factors of a given length for Sturmian sequences

Three and two-distance cases

We assume $\alpha$ irrational


## Two-distance case and Farey points

$N$ - Farey point $0 \leq p / q \leq 1, \operatorname{gcd}(p, q)=1,1 \leq q \leq N$
Let $p_{1} / q_{1}$ and $p_{2} / q_{2}$ be two successive $N$-Farey points s.t.

$$
p_{1} / q_{1}<\alpha<p_{2} / q_{2}
$$

Case $N=q_{1}+q_{2}$ There are $q_{2}$ intervals of length $q_{1} \alpha-p_{1}$ and $q_{1}$ intervals of length $p_{2}-q_{2} \alpha$

Remark The closest points to 0 are $q_{1} \alpha-p_{1}$ and $p_{2}-q_{2} \alpha$ One checks that

$$
q_{2}\left\|q_{1} \alpha\right\|+q_{1}\left\|q_{2} \alpha\right\|=q_{2}\left(q_{1} \alpha-p_{1}\right)+q_{1}\left(p_{2}-q_{2} \alpha\right)=1
$$

## Two-distance case and Farey points

$N$ - Farey point $0 \leq p / q \leq 1, \operatorname{gcd}(p, q)=1,1 \leq q \leq N$
Let $p_{1} / q_{1}$ and $p_{2} / q_{2}$ be two successive $N$-Farey points s.t.

$$
p_{1} / q_{1}<\alpha<p_{2} / q_{2}
$$

Case $N=q_{1}+q_{2}$ There are $q_{2}$ intervals of length $q_{1} \alpha-p_{1}$ and $q_{1}$ intervals of length $p_{2}-q_{2} \alpha$

Remark The closest points to 0 are $q_{1} \alpha-p_{1}$ and $p_{2}-q_{2} \alpha$ One checks that

$$
q_{2}\left\|q_{1} \alpha\right\|+q_{1}\left\|q_{2} \alpha\right\|=q_{2}\left(q_{1} \alpha-p_{1}\right)+q_{1}\left(p_{2}-q_{2} \alpha\right)=1
$$

How to describe the succession of lengths?
Let us consider the map that sends a point $k \alpha$ to its neighbor point when placing $0, \alpha, \cdots(N-1) \alpha$

## A dynamical description for the neighbor map

- We place the points $0, \alpha, \cdots,(N-1) \alpha$
- We consider the map that sends a point $k \alpha$ to its neighbor
- The neighbor map can be described as a permutation over $\{0, \cdots, N-1\}$

- We describe the permutation as the action of an exchange of two intervals.

$$
q_{1}=8, \quad q_{2}=5, \quad N=8+5=13, \quad 3 / 8<\alpha<2 / 5
$$



## Neighbor map and two-interval exchange

We express the permutation of the set $\{0,1, \cdots, N\}$ given by the neighbor map as an exchange of two intervals obtained by translating $\left[0, q_{2}\right)$ by $+q_{1}$, and $\left[q_{1}, q_{1}+q_{2}\right)$ by $-q_{2}$.
This is a permutation since $\operatorname{gcd}\left(q_{1}, q_{2}\right)=1$.
We take the orbit of 0 under the action of this exchange of two intervals.

## Neighbor map and two-interval exchange

We express the permutation of the set $\{0,1, \cdots, N\}$ given by the neighbor map as an exchange of two intervals obtained by translating $\left[0, q_{2}\right)$ by $+q_{1}$, and $\left[q_{1}, q_{1}+q_{2}\right)$ by $-q_{2}$.
This is a permutation since $\operatorname{gcd}\left(q_{1}, q_{2}\right)=1$.
We take the orbit of 0 under the action of this exchange of two intervals.

$$
q_{1}=8, \quad q_{2}=5, \quad N=8+5=13, \quad 3 / 8<\alpha<2 / 5
$$


$0 \mapsto 8 \mapsto 3 \mapsto 11 \mapsto 6 \mapsto 1 \mapsto 9 \mapsto 4 \mapsto 12 \mapsto 7 \mapsto 2 \mapsto 10 \mapsto 5 \mapsto 0$

## Two-distance case and Farey points

$N$ - Farey point $0 \leq p / q \leq 1, \operatorname{gcd}(p, q)=1,1 \leq q \leq N$

$$
p_{1} / q_{1}<\alpha<p_{2} / q_{2}
$$

Case $N=q_{1}+q-2$ There are $q_{2}$ intervals of length $q_{1} \alpha-p_{1}$ and $q_{1}$ intervals of length $p_{2}-q_{2} \alpha$.
Proof

- $q_{2}\left\|q_{1} \alpha\right\|+q_{1}\left\|q_{2} \alpha\right\|=q_{2}\left(q_{1} \alpha-p_{1}\right)+q_{1}\left(p_{2}-q_{2} \alpha\right)=1$.
- The closest points to 0 are $q_{1} \alpha-p_{1}$ and $p_{2}-q_{2} \alpha$.
- One gets a permutation of the set $\{0,1, \cdots, N\}$ by translating $\left[0, q_{2}\right)$ by $+q_{1}$, and $\left[q_{1}, q_{2}\right)$ by $-q_{2}$.
$\sim$ The neighbor map that sends a point $k \alpha$ to its neighbor point when placing $0, \alpha, \cdots(N-1) \alpha$.


## Three-distance case

$$
p_{1} / q_{1}<\alpha<p_{2} / q_{2}
$$

One has

- $N-q_{1}$ intervals of length $\left\|q_{1} \alpha\right\|$
- $N-q_{2}$ intervals of length $\left\|q_{2} \alpha\right\|$
- $q_{1}+q_{2}-N$ intervals of length $\left\|q_{1} \alpha\right\|+\left\|q_{2} \alpha\right\|$

## Three-distance case

One has

- $N-q_{1}$ intervals of length $\left\|q_{1} \alpha\right\|$
- $N-q_{2}$ intervals of length $\left\|q_{2} \alpha\right\|$
- $q_{1}+q_{2}-N$ intervals of length $\left\|q_{1} \alpha\right\|+\left\|q_{2} \alpha\right\|$

$N=10,3 / 8<\alpha<2 / 5$
$+8,+3,-5$


The coding over $\{A, B, C\}$ is obtained as the orbit of 0 under an cexchange of three intervals

$$
\begin{array}{llllllllll}
0 & \mapsto 8 & \mapsto 3 & \mapsto 6 & \mapsto 1 & \mapsto 4 & \mapsto 7 & \mapsto 2 & \mapsto 5 & \mapsto 0 \\
& A & C & B & C & B & B & C & B & C
\end{array}

## Three-distance and three-gap theorems

Three-length theorem [Sós'58] The points $0, \alpha, 2 \alpha, \cdots, N \alpha$ partition the unit circle into intervals having at most three lengths, one being the sum of the other two.

## Three-distance and three-gap theorems

Three-length theorem [Sós'58] The points $0, \alpha, 2 \alpha, \cdots, N \alpha$ partition the unit circle into intervals having at most three lengths, one being the sum of the other two.

The sequence of lengths is a coding of a three-interval exchange on the set $\{0, \cdots, N\}$.

Three-gap theorem [Slater] Let $I$ be an interval of $\mathbb{R} / \mathbb{Z}$. The gaps between the successive integers $j$ such that $\{\alpha j\} \in I$ take at most three values, one being the sum of the other two.

The sequence of gaps is a coding of a three-interval exchange on $I$.

## Higher-dimensional versions

- Linear forms in $d$ variables on the one-dimensional torus $\mathbb{T}$
- Translations on the $d$-dimensional torus $\mathbb{T}^{d}$


## Points $m \alpha+n \beta$ on $\mathbb{T}$

We consider the two-dimensional version of the three distance theorem obtained by placing on the unit circle the points

$$
m \alpha+n \beta \quad \text { for } m, n \text { in a finite set } \mathcal{S}_{N}
$$

$\mathcal{S}_{N}$ can be a square, a rectangle, or a more general shape

$$
\operatorname{Card} \mathcal{S}_{N} \rightarrow \infty \text { with } N
$$

We consider the two-dimensional version of the three distance theorem obtained by placing on the unit circle the points

$$
m \alpha+n \beta \quad \text { for } m, n \text { in a finite set } \mathcal{S}_{N}
$$

$\mathcal{S}_{N}$ can be a square, a rectangle, or a more general shape

$$
\text { Card } \mathcal{S}_{N} \rightarrow \infty \text { with } N
$$

[Bleher et al., Erdös, Liang, Chung and Graham, Chevallier, Geelen and Simpson, Haynes and Marklof, etc.]
$n \alpha \bmod 1 \Leftrightarrow$ Sturmian words $\Leftrightarrow$ Discrete lines $\sim$ Quasicrystals, C\&P
$n \alpha+m \beta \bmod 1 \Leftrightarrow 2 \mathrm{D}$ Sturmian words $\Leftrightarrow$ Discrete planes $\sim \mathrm{QC}, \mathrm{C} \& \mathrm{P}$

## Square shapes

We place the points $m \alpha+n \beta$, for $0 \leq n, m \leq N$ on the unit circle. We consider lengths between consecutive points.
Question Are there finitely many lengths?
Theorem [Holzman] There are finitely many lengths if $1, \alpha, \beta$ are $\mathbb{Q}$-linearly dependent.

## Square shapes

We place the points $m \alpha+n \beta$, for $0 \leq n, m \leq N$ on the unit circle.
We consider lengths between consecutive points.
We assume $1, \alpha, \beta$ linearly independent.
Question Are there finitely many lengths?
Theorem [Boshernitzan and Dyson] Badly approximable vectors $(\alpha, \beta)$ produce a finite number of distances.

$$
\|m, n\|^{2}\|\mid m \alpha+n \beta\| \| \geq C \text { for all }(m, n) \neq 0
$$

Theorem [Haynes-Marklof'17] The number of lengths is generically unbounded.

Proof An approach via homogeneous dynamics based on the ergodic properties of the diagonal action on the space of lattices

- There exist pairs $(\alpha, \beta)$, with $1, \alpha, \beta$ rationally independent, such that

$$
\limsup _{N \rightarrow \infty} \# \Delta_{N}(\alpha, \beta)=\infty
$$

Proof We use regular continued fraction expansions for $\alpha$ and $\beta$ with intertwined sequences of partial quotients. We combine several 'rectangular' levels of points of the form $n \alpha+m \beta$, for $0 \leq n<N$ and $0 \leq m<M$, where $N$ or $M$ is a denominator of a principal convergent of $\alpha$ or $\beta$.

A dynamical approach: the neighbor map as an exchange of pieces

Notation $\quad|n|_{q} \equiv n(\bmod q), \quad$ and $\quad 0 \leq|n|_{q}<q$.
Let

$$
E_{q_{i}, q_{j}^{\prime}}(\alpha, \beta)=\left\{n \alpha+m \beta \in \mathbb{T}: 0 \leq n<q_{i}, 0 \leq m<q_{j}^{\prime}\right\}
$$

with

$$
q_{j}^{\prime}=b^{\prime} q_{i}+1 \quad b^{\prime}>0
$$

A permutation acting on $E_{q_{i}, q_{j}^{\prime}}(\alpha, \beta)$ :
$\phi_{q_{i}, q_{j}^{\prime}}: n \alpha+m \beta \mapsto\left|n-(-1)^{i} q_{i-1}\right|_{q_{i}} \alpha+\left|m+(-1)^{j} b^{\prime} q_{j-1}^{\prime}\right|_{q_{j}^{\prime}} \beta$.
We assume

$$
\left\|q_{j}^{\prime} \beta\right\|<\left\|q_{i-1} \alpha\right\|-b^{\prime}\left\|q_{j-1}^{\prime} \beta\right\| .
$$

Lemma The neighbor point of $n \alpha+m \beta$ is given by $\phi_{q_{i}, q_{j}^{\prime}}(n \alpha+m \beta)$.

This provides a rectangular case where there are only 4 possible lengths.

An analog of the two-distance case



## From 4 to 7 lengths $q_{k}<N \leq q_{k}^{\prime}$

- There are 4 lengths for $\left(q_{k}, q_{k}^{\prime}\right)$.
- We reduce the set of points to $\left(q_{k}, N\right)$. We make an induction and go from 4 lengths to 6 lengths.
- We insert points to reach ( $N, N$ ). We perform an 'exduction' and get 7 lengths.



## Square case

We place on the unit circle the points $m \alpha+n \beta$, for $0 \leq n, m<N$. We consider lengths between consecutive points.

Question Is it possible to find $(\alpha, \beta)$, with $1, \alpha, \beta$ rationally independent, with at most 6 lengths for the square case?

## d-dimensional parallelepipedic case

Let $d \geq 3$.
Let $\alpha_{1}, \ldots, \alpha_{d} \in \mathbb{T}$ and $2 \leq n_{1} \leq \ldots \leq n_{d}$ be integers.
We place the points

$$
\sum_{i=1}^{d} k_{i} \alpha_{i} \quad \text { for } 0 \leq k_{i}<n_{i}, i=1, \ldots, d
$$

Theorem [Chevallier] The number of lengths is at most

$$
\prod_{i=1}^{d-1} n_{i}+3 \prod_{i=1}^{d-2} n_{i}+1
$$

$d=2 \sim$ The upper bound is $N+3$ for $\{m \alpha+n \beta, 0 \leq n, m<N\}$

## Our strategy for Brun shapes

## Our strategy for Brun shapes

- We consider the points $n \alpha+m \beta$, for $n, m \in \mathcal{S}_{N}$, for a family of shapes $\left(\mathcal{S}_{N}\right)_{N}$.
- Theorem [Arnoux-B.-Kim-Steiner-Thuswaldner] Brun algorithm produces shapes $\left(\mathcal{S}_{N}\right)_{N}$ for which there are 3 lengths. These shapes are no more square or rectangular ones (they are approximations of Rauzy fractals).
- The cardinality of points in $\mathcal{S}_{N}$ tends to infinity and the shapes $\mathcal{S}_{N}$ contain a ball of radius tending to infinity with $N$.
- Patterns are obtained by iterating a geometric, higher-dimensional substitution $E_{1}^{*}(\sigma)$ and then, taking a projection from $\mathbb{Z}^{3}$ to $\mathbb{Z}^{2}$.
- The resulting three-dimensional patterns obtained by iterating $E_{1}^{*}(\sigma)$ lie within a discrete plane, i.e., a discretized version of a Euclidean plane with normal vector $(1, \alpha, \beta)$.






## Translations on $\mathbb{T}^{2}$



## Translations on $\mathbb{T}^{2}$

[Vijay] 11 mutual distances Eleven Euclidean distances are enough
[Chevallier] A triangulation of $\mathbb{R}^{2}$ with at most 10 triangles whose set of vertices is $\{0, \alpha, \cdots, N \alpha\}+\mathbb{Z}^{2}$, invariant under $\mathbb{Z}^{2}$-translations, and the maximum of the diameters tends to 0 with $N$. Based on Ferguson-Forcade and Brun algorithm.
[Arnoux-B-Kim-Steiner-Thuswaldner] For a.e. $(\alpha, \beta)$, a tesselation of $\mathbb{R}^{2}$ with at most 6 shapes whose set of vertices is $\{0, \alpha, \cdots, N \alpha\}+\mathbb{Z}^{2}$, invariant under $\mathbb{Z}^{2}$-translations, and the maximum of the diameters tends to 0 with $N$.

- Based on Brun algorithm.
- Pieces are given by subpieces of the Rauzy fractal.
